# 6.0 PUBLIC HEARING: 10:00 A.M.

6.1 CONSISTENT with modifications made, indicated to staff by the Chairman. The Commission struck recommendation B regarding maintenance of a separate log of helicopter operations and recommendation C, which referenced non-emergency operations. As modified, the conditions would be based on use of the facility only for emergency operations for medical purposes as defined in State law. ZAP1001BA07 – San Gorgonio Memorial Healthcare District and Heliplanners/Jeff Wright - City Case No. SP 06-201 (Specific Plan 06-201) - Not in existing Airport Influence Area. **Staff Recommendation:** (Written) - INCONSISTENT due to surrounding land use, but consider for special circumstances due to the need for the helistop to be situated in proximity to the hospital. Oral Recommendation was for a determination of CONSISTENCY, as there are no specific conflicts with ALUC policies, and with revised recommendations for City action.

# 7.0 ADMINISTRATIVE ITEMS

7.1 – <u>Wildlife Hazard Guidance Report</u> – Information only. Staff noted that CDs had been provided to Commissioners, and that the report pertains to Bermuda Dunes and Jacqueline Cochran Regional Airports.

7.2 – <u>Request for Reconsideration – Northgate ZAP1010BD06</u> – Staff had received a letter from the applicant requesting revision of conditions of ZAP1010BD06 to delete the reference to multi-family residential structures as a prohibited use. Staff also notified the Commission that a Notice of Intent to Overrule has been received from the City of Indio.

Applicant representative John Corella requested that the reference be deleted because multi-family residential structures are not specifically prohibited in Zones B1, B2 and C. He requested that this be "cleaned up" so as to be technically correct. ALUC Counsel B. T. Miller indicated that an amendment to the letter could be handled administratively.

**Motion:** Chairman Housman made a motion to reconsider and instruct staff to make the following changes to the prior rulings. "Conditions of approval numbers 3 and 4, second paragraph, the words "multi-family residential structures" be stricken." Seconded by Commissioner John Lyon. B. T. Miller noted that staff will issue an amended letter.

## 7.3 – <u>Executive Director's Approvals</u> – Information only.

7.4 - <u>County FY08 Budget Process Update</u> – Ed Cooper, ALUC Interim Executive Director, came forward with a brief update of the ALUC budget process. An add back request was submitted to the County Executive Office to include \$410,000 in additional funds for professional support including County Counsel and Aviation specialists, advertisements, Commission support, possibly including stipends, and 2 new ALUC planners. Also, a new ALUC fee structure increase will be introduced to the Commission in June or July 2007. The existing fee structure is 15 years old.
