5.0 ADMINISTRATIVE ITEMS

- 5.1 Discussion of ALUC Plan Priorities (Strategic Vision Document) Ed Cooper, ALUC Director presented the Strategic Vision Document to the Commission in order for staff to get a sense of the Commissions priorities for the 2008 calendar year. Vice Chairman Rod Ballance suggested that the airports be numerically prioritized, with consideration of possible future changes at the airports (such as potential expansions, potential triage, runway extensions, etc.). He indicated a need to work closely with the local municipalities as to their vision for their airports. Chairman Housman listed the airport priorities in three separate groups A, B and C listed below:
 - Group A 1) Hemet Ryan, 2) Perris Valley, 3) March Air Reserve Base and 4) Chino.
 - Group B 1) French Valley, 2) Riverside Municipal, 3) Jacqueline Cochran, 4) Blythe.
 - Group C Bermuda Dunes, Corona, Banning, Palm Springs, Chiriaco Summit and Flabob. No airport numbered order was established at this time.

With regard to common issues, the Commission indicated intermediate residential densities and intensity of meeting places need to be addressed.

Chairman Housman commented on the Strategic Vision Plan that we want to get as much of our land uses into the County's General Plan as we possibly can.

5.2 Update on Sanderson Square - Referral from City of Hemet - The City of Hemet determined that rather than approving or disapproving the project at its November 27 hearing, the City of Hemet asked the applicant's team to provide some additional studies depicting Handbook-based safety zones, based on the future runway configurations at Hemet Ryan Airport. ALUC has not yet received a new report from the applicant at this time.

6.0 APPROVAL OF MINUTES: October 30, 2007 and November 8, 2007

October 30, 2007 Minutes - B. T. Miller, County Counsel noted to staff to add Jamie Baldwin and Mark Dillon from Gatzke, Dillon & Ballance, LLP to the minutes as others present. The ALUC Commission by a unanimous vote of 6-0 approved the minutes for October 30, 2007, subject to the correction made by BT Miller.

8.0 COMMISSIONERS' COMMENTS

Chairman Simon Housman and the Commission thanked ALUC staff for their outstanding work throughout the year. The chairman advised that he had participated in a meeting with Kohl Ranch representatives and County staff. Vice Chairman Rod Ballance advised that he had participated in a meeting regarding a proposed hotel within the March Joint Powers Authority area of jurisdiction, and had forwarded the Power Point presentation on the role of ALUC to the applicant.
