Chairman Housman noted Commissioner Glen Holmes' request to have an attendance sheet included in the minutes. Chairman Housman, commenting on item 5.7, where the staff requested direction about the hotel analysis, requested that the minutes be amended to add: "The Commission directed the staff to distinguish between a hotel/motel with a lobby and a few meeting rooms and a large convention hotel which includes large meeting rooms. The lobby and meeting rooms in a hotel/motel should not be analyzed separately. But in a large convention hotel, the convention space should be analyzed separately."

Commissioner Glen Holmes requested that the minutes for item 5.9 Northgate include Chairman Housman's comments and the reference by Mr. Corella to the position of the City of Indio.

8.0 ORAL COMMUNICATION ON ANY MATTER NOT ON THE AGENDA

Staff received a letter from the City of Riverside indicating an intent to override the Airport Land Use Commission on a project that was under consideration by the Commission in 2005 regarding a proposal for additional buildings and Conditional Use Permit for Harvest Christian Fellowship Church. The Commission authorized staff to prepare a response, as staff may deem appropriate.
